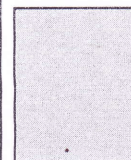

**Agendum**

1. Ratification of introduction of three (3) new courses namely, B. Tech in Computer Science and Engineering (Data Science), B. Tech in Electronics and Communication (VLSI design) and closure of MCA course by introducing MBA (Business Analytics), approved by AICTE and affiliating State Technical University (MAKAUT) commenced from 2020-21 Academic session. Also ratification of the Minutes of the Meetings of BOS and AC related to course structure, curricula and syllabi of the same.

**Resolutions:**

1. Governing Body ratified the commencement of the three (3) new courses namely, B. Tech in Computer Science and Engineering (Data Science) with 60 intakes, B.
